Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs)

The following are the important activities of Department of Consumer Affairs during the month of August, 2019.

1. Consumer Protection Act, 2019:

The Consumer Protection Bill 2019 was passed by Lok Sabha on 30.07.2019 and by Rajya Sabha on 06.08.2019. After assent of Hon'ble President, the Consumer Protection Act, 2019 was published in the official gazette on 09.08.2019.

1.2 Hon'ble Minister of Consumer Affairs, Food & PD held a meeting on 27.08.2019 with Members of Parliament, who participated in the debate in both Houses during passing of the Bill to elicit suggestions / views for making rules under the Consumer Protection Act, 2019.

2. Pulses and Onion Buffer Stock:

- 2.1 A buffer stock of 16 LMT of pulses has been built by transfer from Price Support Scheme (PSS) of DACFW. A buffer stock of 56,689 MT onion has also been created through procurement in Maharashtra & Gujarat, out of which 5,658 MT was disposed during the month of August, 2019. The buffer ensures reasonability of prices and adequate availability and discourages hoarding by unscrupulous traders.
- 2.2 Three Weekly Review Meetings on management of buffer stock under PSF were held during the month of August, 2019. Supply of pulses to Army and disposal of onion from buffer stock were also reviewed in these meetings. Also, two meetings with stakeholders including representative from Delhi APMC, Delhi Admn, NAFED, SAFAL and e-retailers were held to discuss marketing and retailing of Onion, Tomatoes and Pulses in Delhi NCR.
- 2.3 A meeting of Hon'ble Minister of Consumer Affairs, Food & Public Distribution to review the price and availability of essential items was held on 26.08.2019 with DACFW, DFPD and DoC.3.

3. Exempting purchases under contract farming from stock limits:

3.1 An Order has been passed under the Essential Commodities Act as per which, stock limit shall not apply to a contract farming purchaser of any agricultural produce registered under any State Act made in this behalf, subject to the overall ceiling of registered quality. This will lead to –

- Increased investment and technology flow in farming sector,
- Assured income to farmers.
- Increased investment in supply chain activities warehousing, cold storage and cold chain, transportation.
 - 3.2 5th National Consultation Meeting of Minister of States/UTs in-charge of Food, Civil Supplies and Consumer Affairs was held on 03.09.2019 to deliberate on the issues concerning availability and prices of essential commodities, consumer empowerment, one nation one ration card, etc.

4. Bureau of Indian Standards (BIS):

- 4.1 Bureau of Indian Standards (BIS) has been elected to the ISO Technical Management Board (TMB), the apex governance Body of ISO for technical matters for the term 2020-2022.
- 4.2 An ambitious Project for promotion of use of National Building Code of India (NBC) 2016 in all States and UTs of India has been undertaken by BIS. It involves comprehensive review of rules and regulations governing land development and building construction and preparing draft regulations which are aligned with provisions in NBC 2016, for use by the States and UTs.
- 4.3 A **National Laboratory Directory** has been launched by BIS containing data of more than 4000 laboratories with location and product-wise testing facility. Categorisation of labs is on the basis of ISO 17025 accreditation and approval by various regulators, namely, BIS, FSSAI, EIC, APEDA, CPCB.

5. National Cooperative Consumers' Federation of India (NCCF):

5.1 Govt issued order u/s 123 of the MSCS Act, 2002 for supersession of the Board of NCCF and appointment of Administrator on 24.07.2018. The Single Judge in the Hon'ble High Court of Delhi stayed implementation of the same on 31.07.2018. Govt. filed LPA before the Division Bench. Based on order of Division Bench, Govt filed an application before the Single Judge who by order dated 10.05.2019 constituted an interim Board consisting of Petitioner No. 1 (Dr. Bijender Singh, Ex-Chairman, NCCF), Sh. Anil Bahuguna, Jt.Secy, CA (who is appointed as MD by the Central Government) and Justice (Retd) Indermeet Kaur as Chairman of the interim Board. The matter was discussed with the Ld. ASG and based on his advice, an application has been filed in the Hon'ble High Court for having 2 retired Secretaries to Govt. of India on the interim Board instead of Dr. Bijender Singh and the MD, NCCF (who is a non-voting member of the Board). Hon'ble Court vide its order dated 30.08.2019 has acceded to the request made by the Govt.
