Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs)

The following are the important activities of Department of Consumer Affairs during the month of January, 2018:

1. Consumer Protection Bill, 2018:

Consumer Protection Bill, 2018 was introduced in the Lok Sabha on 5th January, 2018. The salient features of the bill include establishment of an executive agency to be known as the Central Consumer Protection Authority (CCPA) which will be empowered to investigate, recall, refund and impose penalties; provision for product liability action in cases of personal injury, death or property damage caused by a product; mediation as an Alternative Dispute Resolution (ADR), e-filing of complaints, etc.

2 Pulses Buffer Stock :

- As on 31.01.2018, the available stock in the pulses buffer is 16.52 lakh MT after disposal of 3.98 lakh MT from 20.50 lakh tonnes procured/imported.
- Disposal of pulses from the buffer is now being reviewed weekly with all the designated agencies by the Department to facilitate the process.
- PSFMC in its 25th Meeting held on 11th January, 2018 also identified another 5 lakh MT of pulses for disposal. Approval of DoE for dynamic reserve price formula for this stock has been sought.

3. Prices of Onions:

 Stock limit on onion was extended till 31-03-2018. States were advised to hold periodic meetings with the hoarders, farmers, retailers and consumer associations at the State and District levels.

Bureau of Indian Standards :

- The 5th annual meeting of the Indo-German Working Group on Quality Infrastructure was convened on January 15 and 16, 2018 in New Delhi. The Indian side was led by me and the German delegation was led by Mr. Stefan Schnorr, Director General for Digital and Innovation Policy at the German Federal Ministry for Economic Affairs and Energy. The Work Plan 2018 was signed for cooperation in identified areas of mutual interest including cooperation in areas of electro mobility, IT Security and data protection, machinery safety, automotive, legal metrology, market surveillance.
- Indian Standards on Petrol and Diesel were revised incorporating BS VI fuel specifications. The major change includes reduction of sulphur content from 50ppm (BSIV) to 10ppm (BSVI).
- Meeting of Assessment Committee was held and approval of Minister obtained granting Modified Flexible Complementing Scheme (MFCS) elevation from Level 'F' to Level 'G' to 14 Scientists/Officers of BIS.

5. Legal Metrology:

- The Legal Metrology (Packaged Commodities) Amendment Rules, 2017 were enforced from 1st Jan., 2018 to include display of certain mandatory declarations by the suppliers on e-commerce platforms, to increase the font size for making declarations on prepackaged commodities, to bring Medical devices which are declared as drugs, under the purview of these rules etc.
- On the representations of Industries, permission was given for making declarations with increased font size by affixing sticker or by stamping or online printing or using a tag upto 31.3.2018.
 Further, Controllers of Legal Metrology of State Governments have been asked not to take coercive action upto 28.2.2018 for font size.

7. Minimum Government, Maximum Governance:

Price Monitoring Cell (PMC) of the Department of Consumer Affairs monitors the retail and wholesale prices of 22 essential commodities on daily basis. These prices are reported by State Civil Supplies Departments on daily basis mainly through online. These prices are disseminated through the Department website immediately. Because of the online price reporting, the time taken to report and for dissemination is less. As per instructions/guidelines even other routine office work is being shifted on line to reduce delays and for more efficient results.
