# DEPARTMENT OF CONSUMER AFFAIRS Monthly Summary for the month of April, 2022

The following are the important activities of the Department of Consumer Affairs carried out during the month of May, 2022:

#### 1. Consumer Protection:

A meeting was held on 27 May 2022 along with various stakeholders including Advertising Standards Council of India (ASCI), E-Commerce entities, Consumer Commissions, Law Universities, Consumer Lawyers, FICCI, CII, Consumer Rights Activists to discuss the magnitude and roadmap ahead for fake reviews on websites.

# 2. Price Monitoring:

- 2.1 Agriwatch's weekly presentations covered the national and international market trends, prices, production, yield, import & export scenario of five pulses-gram, tur, urad, moong and chana, and three vegetables-onion, potato and tomato.
- 2.2 Price trends for the month of May, 2022 over April, 2022 for all India monthly average retail prices as reported by the respective Civil Supplies Departments of States/UTs are attached.

#### 3. Price Stablization Fund:

- 3.1 The 55th meeting of PSFMC was held on 19 May 2022 to review the status of Procurement and Disposal of pulses & Onion under Price Stabilization Fund (PSF).
- 3.2 Rs. 25.29 crore released from PSF to NAFED as 1st installment for procurement of Tur (KMS 2021-22) under PSF.
- 3.3 Rs. 31.75 crore released as 4th installment for procurement of 1 LMT imported Masoor under PSF.
- 3.4 Upto 31 May 2022, NAFED has reportedly procured 52,460.34 MT Onion against the Target of 2.5 LMT to be achieved till July 2022 and 9107.84 MT of Tur against the proposed 42,500 MT of Tur.

#### 4. Bureau of Indian Standards:

- 4.1 A meeting was held on 17 May 2022 under my chairmanship to review the status of formulation of Indian Standards / Guidelines on biodegradable plastics.
- 4.2 464 new licences were granted to domestic manufacturers and two licences were granted to foreign manufacturers. In addition, 2,274 licences of domestic manufacturers and 40 of foreign manufacturers, were renewed.
- 4.3 Department of Chemical and Petrochemicals, has notified 08 Quality Control Orders for various chemical & petrochemicals as per Scheme-I of BIS (Conformity Assessment) Regulation, 2018.
- 4.3 Under the Compulsory Registration Scheme, 471 new licences were issued, 825 inclusions and 309 renewals were done in the month of May 2022. The number of operative licences was 20,368 in May 2022.
- 4.4 Letters have been sent to the CEOs of 100 Smart Cities having Municipal Corporations, regarding testing facilities for Drinking Water, seeking the details of available testing facilities for Drinking Water as per IS 10500 in the laboratories under their organization. Detailed clause wise test requirements were also sent to the municipal commissioners for facilitating gap analysis
- 4.5 Under the Hallmarking scheme, 1398 new jewellers have been registered, and 37 new A&H centres have been recognized during the month.
  - 4.6 To commemorate Azadi ka Amrut Mahotsav, Webinar/Seminar were conducted on 'Quality and Transparency in Procurement of Goods and Services' on 28 April 2022 and on the topic 'Piped Drinking Water Supply System' on 23 May 2022.
  - 4.7 Interaction with Educational Institutions on Standardization held on 10 May 2022 and 13 May 2022.

### 5. Workshop on Legal Metrology:

National workshop on Legal Metrology Act, 2009 was held on 09 May 2022 at Vigyan Bhawan under the Chairmanship of Hon'ble Minister for Consumer Affairs, Food & Public Distribution with Hon'ble Ministers of State Governments, Secretaries, Controllers and Legal Metrology Officers to discuss decriminalization of some of the provisions of LM Act.

#### 6. Time Dissemination:

A meeting under my Chairmanship to review the progress of Time dissemination Project with all stakeholders was held on 30 May 2022.

### 7. ACC directions:

The post of Senior Economic Adviser is vacant since 17.7.2021 after relieving of Ms. Rupa Dutta. The same has to be filled by D/o Economic Affairs being a cadre controlling authority for the post. Hence, no ACC direction is pending with Department.
